### Minnesota Department of Education

Families that have concerns about how schools are handling safety procedures should reach out to their school. If families have concerns that have not been addressed by their school district or charter school, they should contact MDE by emailing [COVID-19.Questions.MDE@state.mn.us](mailto:COVID-19.Questions.MDE@state.mn.us) or calling 651-582-8200.

### Minnesota Department of Employment and Economic Development
