Award of Diploma

District that Awards Diploma

- A student enrolled in a high school or online learning (OLL) program is working toward the graduation requirements of the enrolling school, including both residents and nonresidents.
- A student enrolled in an Area Learning Center (ALC) can choose to earn a diploma from either the resident district or the district in which the ALC is located.
- A student placed for care and treatment at the time graduation requirements are met can be awarded a diploma from the prior high school of enrollment or the district in which the care and treatment program is located.

Rule of Thumb

- The school or program in which the student is enrolled at the time graduation requirements are met reports the student on the Minnesota Automated Reporting Student System (MARSS) with Status End 08 – graduated – without regard as to which district is awarding the diploma.
- This applies whether graduation requirements are met during the school year or during the summer term of an ALC or Alternative Learning Program (ALP) or during traditional summer school.

Student Aging Out

Aging Out: No IEP (Individualized Education Program)

- Eligible for free public education until they earn a diploma or turn age 21. A student who turns 21 after September 1, and who is enrolled, can complete the school year.
 - Student must remain enrolled.
- A senior who reaches the maximum age level without graduation:
 - Status End 40 if the student is enrolled on the last day of the school year.
 - Status End 18 if the student leaves school prior to the end of the school year.
- Refer to *School Attendance Age Limitations* posted to the MARSS Student Accounting website from Minnesota Department of Education (MDE) homepage > Districts, Schools and Educators > Business and Finance > School Finance > MARSS Student Accounting > MARSS Reporting Instructions.

Aging Out: With IEP

- Eligible for free public education until they earn a diploma (meets IEP objectives) or turns age 22. A student who turns age 21 on or after July 1 is eligible to complete the following school year.
- A senior who reaches the maximum age level without graduating:
 - Report Status End 40 if the student was enrolled on the last day of the school year.
 - Report Status End 18 if the student leaves school prior to the end of the school year.

Reporting Procedures and Coding

Reporting Procedures and Coding

Status End Codes Relevant to Seniors

- 08 – Graduates from a public school district/charter school
- 40 – End-of-year, student was enrolled on the last day of school without graduating.

Seniors Who Did Not Graduate

- Student is reported on the current year with Status End 40.
- If the graduation requirements are met during the following summer:
 - Report as a summer graduation on the following year's fall and End-of-Year (EOY) MARSS file.
 - State Aid Category (SAC) 98
 - Status End 08
 - Status Start and End Dates anywhere between July 1 and September 15.

Seniors Who Graduate at End-of-Year While Enrolled at High School

- Student is reported on the current year's EOY MARSS file with Status End 08.
- This applies whether the student is graduating on time, or after the student's cohort has graduated.

Seniors Who Graduate Mid-Year

- The early graduation provision was repealed with the 2011-12 school year.
- Once a student completes graduation requirements and is no longer attending at the school site, the student must be withdrawn and no further membership is reported.
- Status End 08 – graduate.
- Status End Date is last day of attendance and when the graduation requirements were met.

Seniors Who Graduate by Meeting IEP Requirements

- Student on an IEP is exited from special education services upon a student's graduation from high school with a regular high school diploma.
- The term “regular high school diploma” does not include an alternative degree that is not fully aligned with the state's academic standards, such as an attendance certificate or a general education development credential (GED).

Seniors With IEP Who Walk With Class But Return the Next Year for Transition Services

- The student is reported with Status End 40.
- The student is eligible to enroll during the next school year *per the IEP*, unless the student has aged out.
- The student is eligible to receive special instruction and services *per the IEP* from birth until July 1 after the student with a disability becomes 21 years old.
- The student is reported with Status End 08 – graduate – when the IEP objectives are met.

Seniors Who Graduate While Dual Enrolled at the End of the Year

- The school with the later Status End Date reports the student with Status End 08.
 - If the high school record has a later Status End Date than the ALC/ALP, the high school reports status End 08.
 - If the ALC/ALP record has a later Status End Date, the ALC/ALP reports Status End 08.
- The other school reports Status End 99.

Students Who Graduate While Enrolled Only at the ALC

- For students enrolled only in an ALC, the ALC reports the graduation even though the diploma is awarded by another district.
- For example:
 - The student receives an “X” diploma once the student completes graduation requirements while enrolled at the ALC.
 - The ALC reports the student with Status End 08.
- There should be no later enrollment record once the student has completed graduation requirements.

Whose Requirements?

- When a student transfers to an ALC, the student is working toward the graduation requirements as determined by the ALC. The student can choose a diploma from either the resident district or the ALC district.
- However, if a student is taking classes in both the original district and the ALC (concurrent or dual enrolled), the student is working toward a diploma in the enrolling district and will need to meet the district's graduation requirements. The ALC credits are simply going to transfer back to the enrolling district.

Seniors Who Graduate During the Summer Term of an ALC/ALP

- Report as a graduate on the following year's fall and EOY MARSS files.
- ALC or ALP reports the graduation Status End 08.
- There is no later record anywhere after the student completes graduation requirements and is reported as a graduate.
- The high school should not be reporting the student as a graduate if graduation requirements were met while the student was enrolled at the ALC/ALP.
- *This is not a summer graduate / SAC 98 record.*

Seniors Who Graduate During Traditional Summer School

- Report the student as a *summer graduate* with SAC 98 and Status End 08.
- Status Start and Status End Dates are anywhere between July 1 and September 15.
- Report this enrollment record on the following year's fall and EOY MARSS files.
- Refer to *Procedure 12* of the MARSS manual.

Seniors Who Graduate While in Care and Treatment

- The program/school in which the student was enrolled at the time graduation requirements were met reports the Status End 08.
- Example:
 - Student was enrolled in a care and treatment program at the time graduation requirements were met.
 - The district that provides instruction while in care and treatment reports Status End 08.

Summer Leavers

 - Transferred to a Minnesota nonpublic or home school, with proper documentation (request for records from a nonpublic school) (Status End code 03), or
 - Transferred to a school in another state or country, with proper documentation (request for records from another state) (Status End code 05), or
 - Committed to a correctional facility where education is provided but not reported on MARSS and are not enrolled in a Minnesota public school by the last submission for the reporting cycle (Status End code 13), or
 - Passed away (Status End code 11).

Summer Leavers (2)

Graduation Rate Calculation

 - Prior year EOY MARSS is final
 - Current year fall MARSS is final

Graduation Rates: Cohort

- Students are assigned to a grade/year cohort when first reported as enrolled in 9th grade as a Minnesota public school student.
- Student is expected to graduate in four years.
- Students who first enroll in a Minnesota public school in any grades 10-12 are assigned the corresponding cohort.
- Student remains in that cohort, in that school and district, until MARSS reporting indicates graduation, transfer to another school, move out of country/state or passed away.

 - EOY Fiscal Year (FY) **2019** MARSS files: Reported with Status End 08 and are not reported as enrolled on the following fall MARSS files.
 - Fall FY **2020** MARSS files: Reported with Status End 08 on or before September 15, with no later enrollment record, whether or not SAC 98.

Denominator: 2016 Cohort Count

- All students from the original 9th grade cohort
 - plus**
- All students who entered the cohort as 10th, 11th or 12th grade students
 - minus**
- All students who prior to the end of FY **2019**:
 - Transferred to another school's cohort
 - Transferred to an other than a Minnesota public school, including nonpublic/home schools, schools in correctional facilities
 - Transferred to a school outside of Minnesota
 - Moved out of the country
 - Passed away

- Report summer graduates on both the fall and EOY MARSS files.
- Report summer leavers on the fall and EOY MARSS files.
 - Not all of the fall records will impact the four-year graduation rate, but it's easier to report the students rather than determine which ones do not need to be reported in the fall!

Specific Questions

- Does a SAC 98 cause the records to be ignored in some reports/calculations but not others?
 - Yes
- Which Status End codes can be used with SAC 98?
 - 03, 05, 08, 11, 13
 - All dropout Status End codes are valid
- What grade levels are reported with SAC 98?
 - Any student can be reported but the focus is on students that have been included in a graduation cohort – grades 9-12.

Specific Questions continued

- When should a record with a SAC 98 be deleted?
 - Delete the summer record with SAC 98 when the student re-enrolls in a Minnesota public school during the current year.
- What if a student doesn't re-enroll in a Minnesota public school until after the fall reporting cycle is closed?
 - Do not delete the summer SAC 98 record as the student was not re-enrolled prior to October 1.
