Estimated school year 2020-21 general education revenue is advanced to charter schools, one to three years-old, based on the quarterly ADM enrollment projections data submitted on Page 1 of this form. Following June 10, charter schools must submit quarterly updates of the ADM projections. The quarterly updates (September 30, December 14 and April 5) must include a signed, updated projections report. The September 30 and April 5 dates coincide with MARSS submission dates.

If the charter school is unable to submit MARSS data, a roster of students’ names, sorted by grade with begin and end dates of enrollment, must accompany their projections report. On all four dates, charter schools must submit an updated, signed projections report. ADM counts are not automatically updated based on MARSS submissions. Charter schools must be prepared to explain any differences between projected and actual data.

Note: It is important the estimates be as accurate as possible. Under-estimating pupil counts may leave your school short of the necessary revenue to properly serve your students. Over-estimating pupil counts will force the Minnesota Department of Education (MDE) to reduce the general education revenue payments, potentially leaving your charter school with cash flow problems.

These projected pupil counts, ADM enrollment projections, will be replaced with actual pupil counts when actuals become available October 30, 2021, with MARSS.
