Thiab MDE teev cov qib komkawm tau, tsim muaj lub xeev cov ntawv lub xeev thiab ntsuam xyuas seb xeev tau zoo li cas kom muaj kev lees ris haujlwm, thiab muab ntaub ntawv tso cai qhia ntawv, kev qhia thiab kawm xyaum kom paub ntxiv rau cov xib fwb.
