



## Online Learning Course Completion File Timelines

### Submission/Turnaround Reports Fiscal Year (FY) 2020

The Online Learning (OLL)/Course Completion (CC) file is submitted by state-approved OLL programs to request OLL aid for public school students who complete supplemental OLL courses but who are enrolled in another Minnesota school district. These are the reporting timelines for the Online Learning Course Completion files necessary to compute the FY 2020 Online Learning Aid under [Minnesota Statutes, section 124D.096](#).

Manual OLL/CC corrections submitted after August 28, 2020, will be compared to MARSS records in the final statewide edit.	Tuesday, December 15, 2020	n/a	A final statewide MARSS edit is run in January after the manual MARSS corrections are complete. The final Online Learning Student Aid Report will be posted in January.
