



## Expanded Summer Programming Allocations

### Fin 164

The following table provides allocations for \$4.5 million in Expanded Summer Programming funding available to Local Education Agencies (LEAs) not otherwise eligible to receive an ESSER II award under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA). These funds are available to the LEAs who were not identified by the federal government as having a higher need based on economic factors in their communities. The allocation is based 60% on historically underserved populations served and 40% on enrollment in each school. Funds from FIN 164 can be spent to cover expenses between March 13, 2020 and September 30, 2023. Expenditures must be used for actions taken to respond to the needs of students as a result of the public health emergency.

FIN 164 funds may be used for, but are not limited to:

- Offering and planning for expanded summer programs.
- Offering school longer hours or more school days.
- Partnering with community organizations to offer enrichment programs.
- Providing student transportation
- Purchase of personal protective equipment (PPE) for staff.
- Reducing class sizes.
