Waiver	Nationwide vs. Minnesota	Applicable Program(s)	Approval	Expiration Date	Summary
CACFP At-Risk Afterschool Area Eligibility Waiver	Nationwide	CACFP	Automatic	Thursday, December 31, 2020	Allows schools and afterschool care centers to serve meals and snacks to students after the regular school day regardless of the site location.

Definitions

Automatic approval: The waiver automatically applies to all sponsoring organizations and programs without the need to apply to MDE for use.

CACFP: Child and Adult Care Food Program

FFVP: Fresh Fruit and Vegetable Program

MDE: Minnesota Department of Education

MDE approval needed: Sponsor needs to apply for and be granted approval from MDE before being allowed to utilize the waiver.

Minnesota-specific waiver: A waiver that only applies to sponsors and programs operating in the state of Minnesota.

Nationwide waiver: A waiver that is automatically applied to any state that chooses to utilize it.

NSLP: National School Lunch Program

SBP: School Breakfast Program

SFA: School Food Authority

SFSP: Summer Food Service Program

SMP: Special Milk Program

SSO: Seamless Summer Option

Area Eligibility for Closed Enrolled Sites in SFSP and SSO	Nationwide	SFSP and SSO	Automatic	Thursday, December 31, 2020	Allows SFSP or SSO closed enrolled sites to determine site eligibility through area eligibility without collecting income eligibility applications during the public health emergency.

FFVP Alternate Site Waiver	Minnesota Specific	FFVP	MDE Approval Needed	Wednesday, June 30, 2021	Allows FFVP snacks to be served out of a non-elementary site when the approved elementary site is closed due to COVID-19.
School Meals Program Onsite Monitoring Requirements	Nationwide	NSLP, SBP and SMP	Automatic	Wednesday, June 30, 2021	Waives onsite monitoring requirements for state agencies and SFAs in NSLP, SBP and SMP to support social distancing.
Waiver of Local School Wellness Policy Triennial Assessment in the NSLP and SBP	Nationwide	NSLP and SBP	Automatic	Wednesday, June 30, 2021	Allows for the Local School Wellness Policy Triennial Assessment due date to be pushed back from June 30, 2020 to June 30, 2021.
Meal Pattern Flexibility for CACFP, NSLP, and SBP	Nationwide	CACFP, NSLP and SBP	MDE Approval Needed	Wednesday, June 30, 2021	Waives CACFP, NSLP and SBP meal pattern requirements as needed due to the pandemic.
